#### Responsibilities:

- Develop and manage policies and system related to the risk management program.
- Provide subject matter expertise in the risk management including risk analysis, risk register development, contingency analysis, and risk reporting.
- Work closely with the Project Management Division project managers and leaders to support the integration of the risk management principles into the project management plan.
- Lead the risk workshops with project stakeholders to develop comprehensive risk register for the projects including qualitative and quantitative risk analysis techniques.
- Ensure that the risk response strategies are aligned within the PMO risk tolerance criteria and the risks are monitored and managed accordingly.
- Provide guidance and analysis, while making recommendations on risk management throughout the development, evaluation and execution activities of contracts, assessment of deviations to the scopes of work, project estimates and schedules, and form responses on how to deal with their risk impact.
- Conduct regular risk communication meetings, develop reports and presentation related to the PMO risks profile.
- Research and maintain familiarity with existing market and industry related to projects and program risk management and ensure that divisional risk processes and procedures meets industry standard.
   Work closely with the MH Insurance Department and develop project insurance requirements, procure and manage project
- Work closely with the MH Insurance Department and develop project insurance requirements, procure and manage project insurance, responsible for managing insurance claims and documentation.
